Giving thanks

Several Psalms — for example Psalms 105-107 — begin with the words, “Oh give thanks to the LORD.” Psalm 136 repeatedly encourages the giving of thanks: “Give thanks to the LORD ... to the God of gods ... to the Lord of lords.” Then the psalmist provides reasons why we give thanks.

The writer to the Hebrews in 13:15 says:

“Let us continually offer up a sacrifice of praise to God, that is, the fruit of lips that acknowledge his name.”

The encouragement to give thanks — always applicable to Christian living — is certainly appropriate toward the end of November as we celebrate Thanksgiving Day.

Those who travel great distances by automobile or who negotiate crowded airports on some of the airlines’ busiest days of the year demonstrate thankfulness for family. In our Thanksgiving gatherings, because of distance, work schedules, health issues or estranged relationships, not all members of the family may be present. In the midst of heartache and separations — in fact, in all circumstances — our Lord encour-

ages us to give thanks (1 Thess. 5:18). That becomes more challenging when hearts are sad.

Families frequently have traditions established with their Thanksgiving dinner and gathering: preparing traditional foods, checking for Black Friday specials, offering special prayers, enumerating blessings.

One tradition that has developed in our family, initiated by my wife, comes after the meal. While we are still at the table, pencils and pieces of paper are distributed. Each person writes the things for which he or she gives thanks. After these are placed in a container, it is passed around the table and each person draws one out and reads it. Sometimes one easily recognizes the author, other times not. It’s great family relationship-building time.

Those Thanksgiving notations are saved. Last year, we additionally shared the remembrances from several years ago. It was a great activity to see how God had been at work in our family over the past years. There were many



more reasons to “give thanks to the Lord!”

While Thanksgiving Day encourages thankfulness for the physical blessings that God provides, as Christians we also give thanks for the spiritual blessings given by God, especially the gift of salvation through His Son, Jesus Christ.

St. Paul often gives thanks for the congregation to which he is writing. I give thanks to God for the church, for you who are our church workers and lay people. I thank God for your work in the kingdom. I thank God for the freedom to preach, teach and hear the precious Word of God.

Happy Thanksgiving! May God give you a heart filled with thanks for the physical and spiritual blessings in your life!

Church plant is now LCMS congregation

St. Andrew Lutheran Church, Albuquerque, celebrated the official recognition of its constitution and membership into The Lutheran Church—Missouri Synod (LCMS) on Sunday, Sept. 29.



The church plant was started four years ago when members of nearby Faith in Christ Lutheran Church noticed a “Gospel gap” in southwestern Albuquerque. Several area pastors stepped up to serve the budding congregation during its first few years. Then in mid-2017, the Rocky Mountain District partnered with the Synod’s *Mission Field: USA* initiative to send LCMS national missionary Rev. Adam DeGroot to St. Andrew.

Sunday worship was held every week since April 2015.

“Today we constitute into The Lutheran Church—Missouri Synod, and yet it has been for four years — 1,460 mornings — where the Lord’s mercies have been new each day,” DeGroot said during the service. “The Word of God is and shall be preached in this holy house on this day and every day until our Lord’s return.”

Along with DeGroot, participating in the constituting service were Rev. Steve Schave, LCMS director of Church Planting and LCMS Urban & Inner-City Mission, who served as liturgist; Rev. Roger Schlechte, Rocky Mountain District president, who presented the charter; and Rev. John Heffelfinger, Sandia South circuit

visitor, who read the LCMS Constitution membership requirements.

A special video greeting from LCMS President Rev. Dr. Matthew C. Harrison was viewed by the congregation. The charter was signed by all members of St. Andrew in attendance after the service.

A time of fellowship and food was held following the service, which was sponsored by the LCMS Office of National Mission.

Thanks be to God first and foremost, and also to all who attended and have supported and continue to support St. Andrew and the DeGroot family.

Protecting religious liberty

The theme of the 25th annual SOAR Adult Gathering, held Sept. 16-17 at Bethlehem, Lakewood, Colo., was “Religious Liberty—Set Free to Live Freely.”

Rev. Dr. Gregory Seltz, executive director of the Lutheran Center for Religious Liberty in Washington, D.C., was the keynote speaker. Dr. Seltz, former Lutheran Hour speaker, made three one-hour presentations and spoke of his concern about how our religious freedoms are under increasing attacks in a secular society.

A related topic was presented on the First Amendment and the separation of church and state. Seltz said he fully supports the separation of church and state because he doesn't want the government to interfere with the church, especially dictating

who the church can hire and for whom a pastor must perform marriage ceremonies. The Lord has given the church the unique commission to proclaim the Gospel into all the world, and the church should not expect the government to do the work God has given to the church.

Robert Hayes serves as the Trauma Nurse Specialist for St. Anthony Hospital in Lakewood. His topic was to discuss and give practical advice on how to stop bleeding in order to prevent the death of an accident victim. After his talk, two tables were set up to show people how to use a tourniquet and how to pack a wound.
