## REPORT OF THE DISTRICT PRESIDENT

Grace to you in peace from God our Father and our Lord and Savior Jesus Christ!

While the title of this is technically "Report of..." I consider it much more a reflection upon the last three years as I have served as District President, and I want to begin with a spirit of repentance. It would be easy and perhaps "normal" for me to list out in this report all the successes we have had and share aspirations for the future, which I shall still do, but I want to start on a note of humility.

The words of my predecessor, Pastor Schlechte have echoed in my ears time and time again: "Nothing can prepare you for the District Presidency." The learning curve has been extremely steep. I had grand visions of spending lots of time one on one with pastors and other workers for their support and I have been humbled by the geography of this district.

I had grand aspirations of vigorous visitation, and while I made it to a little over 90 congregations, I do feel badly that I could not visit the remaining 75. Similarly, in hopes of strengthening connections with our farther flung congregations, less attention was given to those within and immediately surrounding the Denver Metro area. There are always reasons for this, most of which are understandable as there are only so many hours in a day, yet I have continued to be cognizant of the remaining work still to be done.

When you see Rev. Paul Albers and Ms. Monique Hjalmquist, please thank them profusely! They have in many ways been the backbone of the district for over two decades, but in the last triennium this patience was extended to a new District President, a new Board of Directors (only three members had previously served), and several staffing changes which remain ongoing. Thank you, Paul and Monique! Thank you for your endurance! It is my sincerest hope to add to the District Office staff in different capacities in the next Triennium so that your work can be eased, and that more emphasis can be given to mission and revitalization work and that regular, consistent communication about these efforts can be made!

Much of the time of the Board of Directors this past triennium has been spent discussing how best to further Word and Sacrament ministry within the District. Going forward, we feel it is very important to not neglect the mission field in our own backyard and we pray that as the harvest is plentiful and the workers few, our congregations will generously support this work! And thank you to those congregations who go above and beyond in their support!

In the fourth volume of the Rocky Mountain District History, "Faith to Move Mountains," Rev. Al Schroeder gave what I think is a very fine spirit for us to go forth in as we seek to encourage our congregations and other ministries to reach out in our day and age:

"What drove these bold adventurous men to face frontier hazards, stubborn opposition from unfriendly and sometimes lawless frontiersmen, and physically and mentally strenuous labors? How did they maintain their spirits and their faith? We can be confident that the Spirit of the Church, the Spirit of Christ, filled their hearts with a vision of the power of the Gospel that would turn hearts to Jesus. They were men of hope! They knew that their ministries would shape the frontier. And so their labors did!" – Rev. Al Schroeder

May the Spirit of our Lord Jesus bless the Rocky Mountain District with a "Faith to Move Mountains" and so carry the Gospel of Jesus, the repentance and forgiveness of sins, to the ends of the earth!

## CHAIRMAN'S REPORT BOARD OF DIRECTORS

Dear delegates to the 2025 Convention of the Rocky Mountain District LCMS:

Martin Luther was convinced that the devil was especially active in his day. The church was pressed on every side by heretics and fanatics. In spite of this, Luther emphasized that the hope of the Church is never found in us. It is our Lord Jesus Christ who sustains His church. In 1539 Luther wrote:

God help us as He has helped our ancestors and will also help our descendants to the praise and honor of His divine name throughout eternity! For we are, after all, not the sort of people who could sustain the church. Nor were our forefathers; nor will our descendants be such. But the Lord has done it, is doing it now, and will do it. He says,: I am with you until the end of the world (Matt. 28:20), as is written Heb 13:8: "Jesus Christ the same yesterday and today and forever," and Rev. 1:4: He was, He is, He will be. Yes, that is His name and it is the name of no other Man; nor should it be. (What Luther Says, 833)

We should recognize that the Devil is fiercely active in our day as well. And even though the Church is pressed on every side, is it still our Lord Jesus Christ who sustains His church. He does this in the congregation, through His Means of Grace. God's people gathered around His Word and Sacraments is where God is actively at work to sustain His Church.

As the Board of Directors, we have a responsibility to each other, to the staff in the District Office, to the professional church workers and to member congregations. The focus of our work is always to encourage and enable the congregations in our district in Word and Sacrament ministry around which God's people gather, and through which our Lord sustains His Church.

During the past triennium, the Board of Directors has examined the Gospel Gap Paradigm to determine whether or not it is still serving the needs of the Rocky Mountain District as initially intended. The Gospel Gap Paradigm (GGP) was adopted by the Rocky Mountain District in convention in 2012. It is a circuit based mission model that encourages the congregations within a circuit to identify opportunities for missions and apply for grants. The Board of Directors has regularly approved numerous GGP grants since its beginning. In many ways, the Gospel Gap Paradigm has been a blessing to our District, giving financial support to many important ministries and projects. However, the board recognized that in many ways the program has drifted from its original intent, and there are numerous challenges to having mission work done at a circuit level. It is the board's opinion that the Gospel Gap Paradigm should be retired and that a new model to assist the planting of congregations in the district be implemented. Since the GGP was adopted by the Rocky Mountain District in convention, any change to this model would also need to be approved by us in convention.

At the 2022 convention, the Rocky Mountain District pledged to support the Lutheran Theological Seminary in Novosibirsk, Russia with a goal of raising \$150,000 or more. I am pleased to report that contributions to support this mission exceeded our goal with \$156,652.05 collected. Thank you for your generous giving toward pastoral formation in this challenging mission field. We pray that the Lord would prosper the work of this seminary and the students there who prepare for ministry. I would especially like to thank Polly Wegner who worked diligently to promote this project.

One of the important missions in the Rocky Mountain District is the University Lutheran Chapel located on the campus of Colorado University in Boulder. In recent years, the maintenance of the chapel grounds, which is owned by the district, has been very challenging. During the previous quadrennium (2018-2024) the chapel was renovated, and the important work of ministering to students continues. This chapel is a valuable outreach to the campus community. A special thanks the Pastor Robert Jarvis for his faithful work at ULC. The board recognizes how important it is to support this ministry in the future. In August of 2024, the Board of Directors, in conjunction with the congregation at ULC, approved the Lutheran Church Extension Fund to explore plans to develop the site. I want to emphasize that this is only an exploration. No official plans are

yet in place. The purpose of this exploration is to find ways to improve the property in ways that will sustain the ministry at ULC in the future. A special thank you to Bart Day for his support, and to Chuck Morse, our LCEF DVP, for his work on this project.

I want to thank our entire district staff for their hard work. President Maxwell has been very intentional and diligent in serving the pastors and congregations of the RMD. Pastor Paul Albers work for our schools and teachers in the district is a tremendous blessing. Monique Hjalmquist, the administrative assistant, does an incredible job coordinating all the organizational details of the office. We have a very small staff, especially when we consider the geographical size of our district, and these servants often go above and beyond the call of duty. Thank you!

I want to acknowledge the members of our board who have served in this past triennium: Pastor Jared Melius (First Vice President), Pastor Jason Rust (Third Vice President – Southern), Pastor Michael Redeker (Fourth Vice President – Western), Pastor Eli Lietzau (Secretary), Melissa DeGroot (Commissioned Minister – Southern), Christian Kopff (Lay – Eastern), Damon Tobias (Lay – Southern), Marcia Hogan (Lay – Central), Gary Brookshire (Lay – Eastern), Darrell Wagner (Lay – Western), Russ Winterstein (Lay – Western), Polly Wegner (Commissioned Minister – Central), who moved to Nebraska in 2024 and Sina Williams (Commissioned Minister – Central) who has filled her position. Thank you for your faithful service on the board. It has been a joy to serve with you.

Our District is richly blessed through the ministries of faithful DCE's who nurture the faith of children, youth, and families. It's a remarkable privilege to serve alongside this creative, passionate, and supportive group. Providing critical ministry leadership within our congregations and jointly for the District's efforts are those serving in capacities of Directors of Youth, Christian education, Family Ministry, Child Ministry, Music Ministry, Adult Ministries, and Camp ministry. In all, more than 40 men and women faithfully serve the church in both general and specialized roles! Many of these people serve the District as well, including leadership roles in monthly Affinity Group gatherings.

Many thanks to Ms. Katie Morgan, DCE at Family of Christ, Colorado Springs for serving our District as the Coordinator for the National Youth Gathering. She also makes all arrangements for the District "booth" at the Convention Center and for the District Event during the Gathering.

Lutheran education is a significant part of our heritage. As an example, Zion Lutheran School in Brighton, Colorado celebrated its 125th Anniversary during the 2024-2025 school year! By God's grace many of our congregations continue operating Early Childhood centers and elementary schools and still others support the ministry of our Lutheran High in Parker, CO. A quick review of enrollment and other statistics reveals the great challenges and opportunities. Increasing cost of operations and in many cases declining enrollment are calling for new financial models and innovative forms of funding. Nationwide trending shows a decrease in the number of elementary and early childhood schools (see the following page for an LCMS report). Additionally, we have a minimal number of graduates from our Concordia's with an undergraduate degree in Lutheran Education. Please see the following pages for a report from our Concordia universities' Undergraduate Placement Directors.

To the glory of God, our nearly 500 educators maintain a servant-hearted focus as they proclaim the Gospel message in a clear manner to students and families. We rejoice that God's name is proclaimed in 27 Early Childhood Centers, 21 elementary schools (most of which have ECC programs) and two high schools spread throughout the District.

By God's grace none of our preschools or elementary schools closed during the triennium. In fact, thanks be to God, we have two "new" schools. Redeemer Lutheran preschool in Delta, CO expanded their program to include elementary grades and a new building! Check it out at <a href="https://www.redeemerlutheranschool.org/">https://www.redeemerlutheranschool.org/</a>. Immanuel Lutheran School in Loveland, CO expanded their ministry to include a high school model that is "education reimagined." (<a href="https://school.immanuelloveland.org/high-school/">https://school.immanuelloveland.org/high-school/</a>).

During this triennium I've served on the Board of Directors for the Colorado Association of Private Schools (<u>https://www.coloradoprivateschools.org/</u>). We've worked earnestly to rebuild a formerly inactive effort in the state. The number of enrolled schools doubled and nearly \$200,000 of grant-based funding was secured. We seek to be the voice of PK-12 private education in Colorado and we're a member of the Council for American Private Education. We engage as we're able on state policy issues, most predominately the last few years we've helped our schools navigate Universal Preschool (UPK) and attempted to influence procedures and policies at the state level. I am thankful to President Maxwell and the District's Board of Directors for allowing me to serve in this capacity and for their support of CAPS efforts on behalf of our schools.

I'm grateful to God for a strong partner in ministry, Ms. Monique Hjalmquist. Her heart for Jesus, strong administrative skills, an eye for details and love for church workers are blessings to the Rocky Mountain District.







## **DEBT ASSISTANCE PROGRAM**

Debt Assistance Program (DAP)

Educational debt continues to impact on our pastors and other church workers. Pastors can accrue significant debt from undergraduate and seminary studies. This can add financial stress to a pastor's ministry and impact the length of his stay at a particular congregation.

The potential for significant debt may also deter otherwise qualified men from studying for the pastoral ministry. Although both seminaries of the LCMS announced in 2018 that they will now cover 100% of the tuition for church-work students, there are still non-tuition expenses such as housing and food, insurance, books, supplies, and miscellaneous fees.

Since 1998, the Rocky Mountain District's Debt Assistance Program (DAP) has assisted District pastors with their educational debt. In the last 3 years since our last District Convention reporting, a total of \$26,796 has been distributed to District pastors who've applied for this assistance. \$5,953 was distributed to 6 pastors in 2022 (FY2023), \$9,184 was distributed to 6 pastors in 2023 (FY2024), and \$11,659 to 3 pastors in 2024 (FY2025).

The average educational debt of the program changes from year to year. Previous applicants that re-apply to the program see their debts decrease, while the addition of new pastors to the program can increase the overall program average. The average educational debt per applicant over the past 3 years was \$20,909.

Due to various factors from year to year, including economic conditions, financial gifts received and fund interest rates, the fiscal year-end endowment fund balances are as follows..... \$436,837 - 1/31/2022 \$434,096 - 1/31/2023 \$441,908 - 1/31/2024 \$462,561 - 1/31/2025

As we do each and every year, we thank God for His blessings through the faithful donations of our congregations, the Lutheran Women's Missionary League, congregational women's groups and those dedicated individual donors, all who help the Rocky Mountain District assist the pastors of today and tomorrow.

## SCHOLARSHIP GRANT REPORT

#### Rocky Mountain District Scholarship Grant Report

The Rocky Mountain District is blessed to provide tuition assistance in the form of grants to students who are members of the district attending any Concordia Seminary or University. Tuition assistance is primarily made through endowment funding from generous families and individuals who name the Rocky Mountain District Scholarship Fund as benefactor. This tuition assistance is provided for those applicants whose academic studies are primarily focused on the goal to become future church workers, such as pastors, educators, DCE's and similar professions. Grants are typically awarded by late Summer or early Fall of that academic year that assistance has been applied for.

The past triennium has been filled with the Lord's blessings amid the cross for the saints in southeastern New Mexico. God be praised that our congregations are nourished with Christ, the Bread of Life (John 6:51), through both faithful preaching and right administration of the sacraments. By his Holy Spirit we have been given the strength to endure in hope. Amid the trials and tribulations of life, including two major natural disasters in Ruidoso and Roswell, the saints have sought refuge in prayer. Those petitions have been answered by the Lord who has filled Christian hearts with generosity, either within our own congregations or from far away, to give selflessly to the needs of our members who have lost their homes and possessions. We have also shared the sorrow of the saints of Immanuel Lutheran Church in Artesia at the closing of their congregation. Nevertheless, we have every confidence that "for those who love God all things work together for good" (Romans 8:28). Even now, Pastor Wright and the saints of Immanuel Lutheran Church in Carlsbad are working hard to reach souls in need of the comfort of the Gospel. We ask the district to pray that the Lord uses their efforts to plant a church in this community.

We continue to enjoy a cordial and strong brotherhood among the pastors and communion between the saints. Without a doubt this is due to our tradition of mutual study of the Scriptures and our Lutheran Confessions. Remaining faithful while bearing up under the devil's temptation and the world's distractions is difficult. Isolated and alone we would fall as prey to the wolves. God be praised that our ears and hearts are open to correction and instruction. Our discussions are lively and full of good humor. Instead of fleeing each other's company, we seek it out.

**Shepherd of the Hills, Ruidoso:** Over the last three years SHLC has faithfully managed challenges presented to the community. The church continues to deal with the fallout from the major transitions of various families that resulted from the upheaval that covid restrictions presented. A number of key leaders took that time to move for various reasons. In 2022 the community was affected by the McBride fire and then again this last summer with the Southfork and Salt fires. While there has been a change in leadership, the Lord has faithfully raised up couples and families that have moved into the area and have taken up the responsibilities necessary to continue to function for the sake of Word and Sacrament ministry. The church was able to raise \$180,000 to help with families impacted by the fire. SHLC has stood up a Lutheran Early Response Team. With generous donations and a grant from the Synod the church has bought and equipped a trailer to respond to local and regional emergencies. The saints at SHLC look forward to continued outreach and mercy work opportunities in and around Lincoln County, NM.

**Immanuel Lutheran Church, Clovis:** This past triennium, Immanuel in Clovis has seen few changes, numerically speaking. Officers of the congregation have generally remained the same. We've had a few visitors, an infant and adult baptism and confirmation (2023), and three (2 adult) confirmations (2022). Two members died in the Lord. As the congregational members are aging, we are reflecting on ways for providing needed care, first, being aware of the various needs. The elders have been studying a helpful book by Rev. Tim Mech, *Pastors and Elders: Caring for the Church and One Another*. In addition to this study for the elders, a number of study opportunities for members are offered weekly, including a study of the Lutheran Confessions, Wed morning Bible study, and Evening Catechesis. Topics of studies have included "Christians in a Woke World," "The Liturgy of the Divine Service" Thessalonians, Peter, "Christianity: The First Three Centuries", and Acts of the Apostles. The Lutheran Women in Mission (LWML) is quite active. Pastor Reeder serves as the Zone Pastoral counselor. The women of Immanuel, Clovis and Faith in Christ, Portales, meet once a month for a meal, Bible study, and meeting. Financially, the congregation seems to be doing quite well. The budget has increased and is increasing. Giving seems strong.

**Faith in Christ Lutheran Church, Portales:** Faith In Christ continues as a small congregation with its emphasis on Word and Sacrament, with both Sunday and mid-week Divine Services. A couple of critical families have moved and left us a bit smaller with fewer leaders. Since we have five ENMU instructors in our congregation, outreach continues strongly to the college students.

**Grace Lutheran Church and Our Savior Lutheran Church, Hobbs and Lovington:** Pastor Kyle Brown received and accepted a call to Indiana in April - May 2024. He was our Pastor since June 2019. We miss him and his family. Both congregations voted to call Pastor Thaine Kister in July 2024. He accepted and was installed on September 8, 2024. Pastor Kister and his wife, Val moved to Hobbs from Los Lunas, NM. Their move to SE New Mexico was well received as they have lived in our state since 2019. Divine Service with Holy Communion & Bible study is appreciated every Sunday at each congregation and Wednesday night at Grace led

by Pastor Kister. Val leads a women's Bible study on Saturday morning which is also appreciated. Grace has had some faithful members move to new locations out of our area over the last year which has been difficult. We hope and pray that our churches continue to be fed with Gods' Word and Holy Sacrament as well as those who need a loving church home.

Immanuel Lutheran Church, Carlsbad: Immanuel Lutheran Church of Carlsbad, NM, strives to build up Christ's people through hearing the Word and living as brothers and sisters in Christ. Our Mission Statement is: "We are a Christian family, growing on God's Word and sharing the love of Jesus Christ." We carry this mission through by recognizing our familial attributes in a positive way, continuously and faithfully hearing God's Word read, proclaimed and referred to at every worship, Bible study or business meeting. Through public relations efforts, employing a new website and also use of a Facebook page, we offer, publicly, such worship and study meetings so that all attendees may partake in God's grace, received through His Word and Spirit. The Sacraments as always are also being rightly administered at Immanuel. Our Children's Sunday School continues to thrive with kids between three and thirteen years old using standardized lessons provided by CPH. Although there are challenges for our small but thriving family of faith, membership and worship attendance has been stable, and we have also been blessed to receive a few new members. We repent of our tendencies to seek individual preferences, and we ask the Lord to guide us to seek what is for the common good (I Cor. 12:7). Though our sister congregation with whom we previously formed a dual parish, Immanuel Lutheran Church, Artesia, NM, has closed, we still minister to the former members at Artesia. We pursue evangelism outreach efforts there and our current program, HOPES (Helping Our Students Excel in School) is mercy work for helping elementary aged children. This work leads to some introspection about how the Lord may lead us beyond just a tutoring and mentorship program into how we might be able to catechize unchurched people so that they, too, are part of Christ's family of faith, the church. Strategies are being developed for evangelism outreach to be sustained. Christ's people and pastors of our Pecos Circuit, as well as RMD leadership, have been prayerfully supportive in advancing these strategies.

**Immanuel Lutheran Church and School, Roswell:** Over the past three years we have experienced a decline in active membership. Many of our families and individual members have moved away either for reasons of employment or retirement. Other beloved members have been laid to rest and taken to their heavenly home. New members have joined, but not enough to make up for past years' attendance numbers. Nevertheless, our congregation strives to bring the Gospel to the members of our community. We pray the Lord again fills our pews with saints eager to be comforted by Christ's gifts and to grow in love. God be praised that Pastor Tyler Holt has served our congregation well as the school's headmaster and our associate pastor. His leadership in the school and unwavering confession has introduced many children and whole families to the saving truth of the Gospel. We give thanks for his service and for our teachers' hard work. Also of note was the flooding that struck our city this past autumn. Thankfully most of our members' homes and possessions were spared. The church building and premises were also undamaged. However, one family lost everything. Through help coming from unlikely places, the Lord has given them the ability to rebuild. Pastor A. Brian Flamme continues to serve as Senior Pastor and Circuit Visitor.

**Pecos Circuit Forum 2025:** Pastor A. Brain Flamme was elected as Circuit Visitor. Pastor Jason Rust led a brief study on the nature and work of a circuit of congregations. Four overtures were discussed and three submitted to the district.

- **Peace, Arvada** Pastor Dave Ahlman retired in July of 2022. Pastor Guy Roberts was installed as senior pastor in February of 2024. Pastor Tom Kent (emeritus) was received into the church triumphant in late 2023.
- **Shepherd of the Rockies, Bailey** Pastor Pete Scheele retired in July of 2024. Pastor John Graham was installed as sole pastor in September of 2024.

**Circuit Pastor Gatherings (Winkels)** – We meet 9 months of the year on the first Wednesday of the month from 12-3pm. We have about 10 pastors at our gatherings. Our gatherings typically include a mealtime during which we share and pray for one another, Bible/topical studies, worship, and circuit business.

**Missions** – Our circuit has been working closely with Summit Mission Alliance (<u>www.SummitMissionAlliance.org</u>) to address some of the opportunities for mission in our circuit. Summit Mission Alliance prepares, plants, and provides for missionaries in the central Colorado mountains. Its goal is to plant ten missionaries in a ten-year period.

- **Leadville, CO** Summit Mission Alliance (SMA) has been in covenant relationship with Good Shepherd, Leadville for several years. SMA has provided Good Shepherd with pastors for Word and Sacrament ministry and pastoral care during that time. Our district has contributed financial support for the mission work in Leadville via Gospel Gaps grants. That work includes recent renovations to Good Shepherd's parsonage. In August of 2024, Pastor Dale Critchley accepted a Call from SMA to serve as Missionary to Leadville. He and his family live in Good Shepherd's parsonage.
- **Granby, CO** The Lord has been bringing people together for a potential new church plant in Granby. Currently, the LCMS has no official presence in the entirety of Grand County. SMA has been working to coordinate the gathering of people in Granby and hopes to call a pastor to serve there in 2025.

#### **CIRCUIT 3-DENVER SOUTHWEST**

Denver Southwest Circuit Report Rocky Mountain District Convention May 29-30, 2025 Prepared by Pastor John Larson

Since 2022 there have some changes and many gifts of grace in the congregations of the Denver Southwest Circuit:

**Ascension in Littleton** has been blessed by a strong laity desiring to serve their Lord and community. The congregation of 500 baptized have been led by Pastor John Larson since 2005. Michael Zehnder, though partially retired, still oversees the music ministry in the congregation. DCE Stephanie Roettjer celebrates three years in service at Ascension in 2025.

**Holy Cross in Highlands Ranch** has been led by Pastor Bruce Skelton for the past 21 years. Holy Cross and Pastor Skelton have been instrumental in guiding 5 men into the Holy Ministry, and 2 Deaconesses into service in the church. The congregation also is greatly invested in providing ministry to Windcrest, a large retirement community in Highlands Ranch. Pastor Skelton and the church have ministered there for about 15 years.

**Shepherd of the Hills in Centennial** has seen a number of changes in these past three years. Pastor Greg Zillinger who served as Associate Pastor for many years, accepted the call to be the Pastor at Holy Cross in Colorado Springs. He concluded ministry at Shepherd in late February of 2024 and was installed at Holy Cross on March 3, 2024. The congregation is seeking to call an Associate Pastor. Pastor Brad Stoltenow, who has been at Shepherd for the past 18 years is thrilled to have DCE Sina Williams on staff for the past 2 years.

**Renewal in Denver**, a satellite church plant of St. John's Denver, has been blessed by its first resident Pastor, Rev. PJ Aarsvold, over these last three years. PJ was installed on June 12 in 2022. Renewal, which worships in the former Emmaus Lutheran Church building, are seeking to reach the ever-changing neighborhood in the Highlands area of Denver. They seek to engage the neighborhood through a variety of community events. They emphasize a strong program of assimilation for their new members.

**Immanuel in Englewood**, the second oldest congregation in the circuit, will celebrate their 100th anniversary on Sunday, August 24, 2025. Pastor Jim Tuell, will celebrate 8 of those years, first serving as the vicar beginning in April of 2017 and then as their sole pastor beginning in October of 2019. The congregation has been instrumental in serving the needs of the homeless population in the Englewood area, serving as an overnight host congregation for up to 40 folks more than 100 nights during the winters in 2023 and 2024.

**St. John's in Denver**, established in 1879, the mother church of many of the congregations in Denver, continues a dynamic ministry with their active congregation and their large day school. Andrew Farhat is the lead pastor, following the call of AJ Mastic in January of 2022 to Pathfinder in Ellisville, Missouri.

**Trinity in Denver** is a leader in the circuit in their ministry to home schooled children and their parents. They have formed a co-op that supplements academic lessons taught at home and provides a solid formation of Lutheran teaching. Pastor Adrian Sherrill serves as Senior Pastor. From 2022 until 2024 Pastor Sherrill was assisted by Rev. Dr. Adam Koontz. Pastor Koontz now serves at Redeemer in Oakmont, Pennsylvania.

**Hosanna in Littleton** is led by Pastor Greg Peters and has been led by him for a number of decades. The congregation serves the western side of Littleton with great love and compassion.

**Redeemer in Denver**, though closed some years ago, was bought by the city of Denver to be part of the Denver Public Library System. The name of that branch is **Westwood Redeemer Library**.

The Longs Peak Circuit regularly meets for Winkel on the third Tuesday of the month from 8:30am until 12:30pm. Victor Young as assistant pastor for Faith, Johnstown. God be praised for His goodness and mercy toward the saints of the Longs Peak Circuit.

Circuit Visitors Report Circuit 5 - Sandia North Rev. Douglas K. Escue, Circuit Visitor Immanuel Lutheran Church, Santa Fe, NM

The Sandia North Circuit consists of 11 congregations located in north central and northeastern New Mexico cities and rural towns (metropolitan Albuquerque, Santa Fe, Los Alamos and smaller towns).

The congregations (year established and current pastor) in northeast metropolitan Albuquerque area include: *Christ Lutheran Church & School* (1960, Rev. Eric Robinson); *Christ our Redeemer Lutheran Church* (2025; Rev. Bruce Wilder; *Grace Lutheran Church* (1985, Rev. Aaron Richert). In the East Mountain area east of Albuquerque are *Prince of Peace Lutheran Church/Cedar Crest* (1984, Rev. Michael Feuer; associate Pastor, Rev. Doyle Boykin); *Good Shepherd Lutheran Church/*Edgewood (1988, Vacant). Farther north (*del Norte*) are *Immanuel Lutheran Church/Santa Fe* (1938, Rev. Douglas K. Escue); *Redeemer Lutheran Church/Los Alamos* (2008, Rev. Johannes Nieminen); *Immanuel Lutheran Church/ Las Vegas* (1921, Vacant); three congregations: *Christ Our Savior Lutheran Church/Angel Fire* (1982), *Sangre de Cristo Lutheran Church/Taos* (1993) and *Immanuel Lutheran Church/ Springer* (1950) are served by SMP Vicar, Ben Davis.

Six of these congregations are served by full-time Pastors; two congregations are vacant; three congregations are served by an SMP Vicar. In addition to several Commissioned Ministers serving at three parochial schools, two congregations have Directors of Christian Education, each.

Sandia North congregations consist of a combined communicant membership of approximately 600 souls. Christ/Albuquerque operates a parochial school (pre-K through 8th grade); Grace/Albuquerque and Immanuel/Santa Fe both sponsor Pre-kindergarten schools, respectively. Christ/Albuquerque continues to operate its God Cares about You human care ministry.

Notable events during the past 2022-2025 triennium include:

- Redeemer/Alb., formed in 1951, decided to close and join with Faith in Christ/Alb. to become Christ the Redeemer/Alb (Jan. 2025). Redeemer/Alb. held a concluding service in December 2024, with current and former members and former Pastors in attendance. Prayers of thanksgiving for 74 years of faithful ministry, were offered by sister congregations.
- the service of SMP Vicar Ben Davis for Sangre de Cristo/Taos, Christ our Savior/ Angel Fire and Immanuel/Springer congregations began in August 2022 (Pr. Doug Escue, Immanuel/Santa Fe, serves as the SMP Vicar's Mentor; Vicar Davis' Ordination is scheduled for August 2025).
- the installation of Rev. Aaron Richert, Grace/Albuquerque (June 2023).
- the installation of Rev. Johannes Nieminen, Redeemer/Los Alamos (June 2023).
- the installation of Rev. Dr. Bruce Wilder, Christ the Redeemer/Alb, Jan. 2025 (NB: Christ the Redeemer was created out of two congregations—Redeemer/Alb. (1951-2025) & Faith in Christ/Alb. (1978-2025)—choosing to form one congregation).
- Other noteworthy activities: pastoral retirements of Rev. Phil Spomer, Good Shepherd/ Edgewood (Dec. 2025), and the Rev. Donald Neidigk as part-time Pastor Immanuel/Las Vegas (July 2025).
- Commissioned Minister Melissa DeGroot (Calvary/Rio Rancho) and layman Damon Tobias (Immanuel/Alb.) were elected to serve as members of the Rocky Mountain District Board of Directors for the 2022-2025 triennium.

While existing as two separate circuits, Pastors in the Sandia North and Sandia South circuits continue to meet jointly for substantive monthly Winkels (Pastors' meetings) during the months of September through May for study, worship, discussion and sharing, as well as for circuit forums and joint ministry endeavors. Grace/Albuquerque sponsors summer continuing education Seminary classes from Con. Theo. Seminary, Ft. Wayne. Immanuel/ Santa Fe sponsors summer continuing education Seminary continuing education Seminary classes from Con. Seminary classes from Con. Seminary/St. Louis.

Both circuits (Sandia North—11 congregations, and Sandia South—6 congregations), after careful consideration to combine to form one circuit, concluded to remain as two circuits but request the realignment of congregations in the new triennium.

#### Trinity Alamosa – Rev. Jason Cody

Rev. Jason Cody is in his 9<sup>th</sup> year at Trinity. The congregation continues to grow receiving new members and continuing in the growing school ministry of Trinity Lutheran School. Recently Dr. Gabe Jardon, a member of Trinity, has applied for colloquy with the LCMS.

#### St. Peter Monte Vista - Vicar Joshua Cody

After two years of service, intentional interim Pastor Rev. Robert Hauter completed his work at St. Peter's. In the summer of 2023, the congregation chose to pursue the raising up of a pastor from within itself. Joshua Cody was elected from among the congregation to become the SMP Vicar and enrolled in Concordia Theological Seminary Fort Wayne, IN. He was installed as Vicar on August 30, 2023, under the supervision of Rev. Ben Delin. St. Peter's has continued to maintain summer preaching station in Creede. CO.

#### Hope Westcliffe – Rev. Dan Kletke

Rev. Dan Kletke has been filling the vacancy at Hope since November 2021. 2022 marked the congregation's sesquicentennial (150 year) milestone; and the congregation celebrated with a celebratory service on August 21<sup>st</sup> that saw beloved pastor Wayne Riddering return to preach, followed by a German themed dinner. The congregation has recently begun the call process with a lot of hope and expectation.

#### St. John Cañon City - Rev. Dan Kletke (Circuit Visitor)

Rev. Kletke has now been at St. John for 13 years. The congregation recently purchased and installed new pews which finished upgrades to the facility. The congregation continues to reach out to the community and beyond Cañon City; and they are currently preparing for Rev. Kletke to take a 3-month sabbatical the fall of 2025.

#### Bethany Pueblo & Our Savior Pueblo West - Rev. Nicholas Shults

The dual parish of Bethany & Our Savior's continues to be served faithfully in many capacities by dedicated lay leaders. Both congregations are eager to work collaboratively to bring the Gospel to those in Pueblo and Pueblo West. Rev. Shults has served as pastor of the dual parish since his installation in October 2021.

#### Trinity Pueblo – Rev. Robert Hauter

In 2023 Rev. Randy Bolt retired after 40 years of ministry (27 at Trinity Pueblo), and Rev. Bob Hauter was installed as the Intentional Interim Pastor in October. In 2024 our new principal, Dr Derion Ibarra, was hired and our Early Learning Academy Director, JoAnn Collins was awarded the ELA Director of the year by the RMD. Trinity will begin the call process to call their next pastor in 2025.

#### St. Peter Rocky Ford – Rev. Kelly Leary

St. Peter has been vacant for several years. The vacancy is now served by Rev. Kelly Leary.

#### Trinity La Junta – Rev. Rick Miller

Besides all the typical aspects of ministry (with help from the Ruth Guild and Youth Group), the Congregational Family shared our chapter-a-day Bible Journey through the Old Testament's Writings, New Testament and Torah, as well as reached out to the community in a variety of ways (including support of the local Food Bank and Pregnancy Center; having a Float in two Parades; hosting Concerts by "New Legacy Project," "Jubilate" and "Luke Yates;" sharing Presentations about Bulgaria and Japan; holding Advent Services at the local Theater with free Christmas movies; offering a free Theater-showing of "The Easter Experience" and having an "M&Ms Gospel" booth at the Otero College "Frost-Fest"), all culminating in the celebration of our 100<sup>th</sup> Anniversary.

#### **CIRCUIT 7-NORTHEAST**

Brothers and sisters in Christ, attendees of the 2025 Rocky Mountain District Convention, greetings to you in the name of our crucified and risen Lord, Jesus Christ.

The Northeast Circuit is comprised of twelve congregations, two of which are located in Nebraska. One of the Circuit congregations is non-calling and served by a Rev. Richard von Steinmann of 1st English Lutheran in Sterling, CO. There are two dual-parish congregations in the Circuit: St. Pauls, Julesburg, CO and Zion, Big Springs, NE; also St. Pauls, Amherst, CO and St. Pauls, Venango, NE.

At the 48<sup>th</sup> RMD Convention in 2009 with the introduction of the first graduates from the Lutheran Hispanic Missionary Institute, El Paso, Texas by Executive Director Rev. Richard Schlak, the Holy Spirit planted a seed. The planting of that seed grew into what was to become the Northeast Circuit Hispanic Outreach (NECHO). NECHO had its official beginning with the call to and the installation of Rev. Armenio Pineros as its first missionary on February 12, 2012. Pastor Pineros was called to the Circuit through Trinity, Sterling, CO and first established a Hispanic worshipping community there. In 2016 Pastor Pineros began outreach activities in the largely Hispanic populated community of Holyoke, CO. We in the Northeast Circuit are so thankful and blessed to have had Rev. Armenio Pineros as part of our Circuit until his retirement in January of 2017.

Again, by the blessing and guidance of the Holy Spirit, the Northeast Circuit extended a Call to and installed Rev. Pedro Jofre on March 12, 2017 as the NECHO missionary to continue the work begun by Pastor Pineros. On March 25, 2018 Pastor Jofre's wife Erica Jofre was commissioned and installed as Deaconess serving alongside her husband in NECHO. On a given Sunday roughly 30 souls are worshipping at Trinity, Sterling and 30 are worshipping at Zion, Holyoke. Pastor and Deaconess Jofre also lead catechesis, Bible Studies, ESL and Spanish as a Second Language classes at Sterling and Holyoke. Praise to the Lord!

As of March 24, 2025, the Northeast Circuit is as follows:

Trinity, Fort Morgan began being served by Rev. Bror Erickson in early 2023. They are currently in the midst of a building project for a new sanctuary on the ground next to their school on the west side of Ft. Morgan.

Trinity, Sterling, CO Rev. James Nash retired at the end of 2024. They are currently being served in vacancy by Rev. Pat Riley.

First English, Sterling, CO is served by Rev. Richard von Steinman.

- NECHO is served by Rev. Pedro and Deaconess Erica Jofre who submitted: My name is Pedro, we come with my family from Argentina and 5 years ago I was called to serve in northeast Colorado, and for me it has been an incredible experience, seeing how God is raising up his chosen ones showing his saving power in small towns but where it is also necessary to do the task of evangelism. Working with this circuit has taught me how God blesses the unity of the Church even if we speak in another language and I give thanks for being able to be part of the history of what God is doing in this town. The power of the gospel bringing life through the cross and the act of love that Jesus had with us is a beautiful thing.
- St. Pauls and Zion, Julesburg, CO and Big Springs, NE are served by Rev. Trenton D. Christensen. Julesburg is the site of an Orphan Grain Train warehouse where the members of St. Paul, and volunteers from surrounding communities are active in the receiving, sorting, and shipping of clothing and materials to the needy around the world. Since the 1980's St. Pauls has had a midweek program for 3<sup>rd</sup> through the 6<sup>th</sup> grades. In the fall of 2017 Zion began its own midweek program. Thanks to a grant from LCEF, St. Pauls was able to purchase and install hi-def video equipment in January for recording and posting of services on YouTube.
- Immanuel, Haxtun, CO is served by Rev. Timothy Hahn who was installed as pastor on October 3, 2021.

- Zion, Holyoke, CO is served by Rev. Gary Rahe who submitted: Zion, like all congregations with the circuit and district, found the pandemic a very challenging time. Prior to the beginning of the shutdown, we were in the midst of a renovation project. Our committee had been meeting about a year and a half and were about to make a report to the congregation about a recommended project. That all was suspended. The project has begun again following COVID and is moving forward. We are back to full activity and are now preparing for a renovation and maybe even a building of new facilities. Time will tell just where God wants us to go.
- St. Pauls and St. Pauls, Amherst, CO and Venango, NE are served by Rev. Kurt Hatteberg.
- Trinity, Akron, CO (non-calling) is served by Rev. Richard von Steinmann of 1st English Lutheran Church, Sterling, CO.
- St. Johns, Yuma, CO is served by Rev. Dennis FitzPatrick who has submitted: Word and Sacrament ministry continues faithfully in Yuma this past year. Worship has returned to closer than pandemic levels of 2020. Wednesday night supper and Bible study, alongside Confirmation and Youth Night have begun again and are doing well. We are again, working to bring Hispanic Ministry to our area as this becomes an ever-increasing need to our diverse area. This is our 3rd year calling for a Vicar to service St. John's and our Yuma community.
- Calvary, Wray, CO was served by Rev. Timothy Davis whose last Sunday was January 23, 2022. After an almost 3 year vacancy, served by Rev. Dennis FitzPatrick of St. John's Lutheran, Yuma, Rev. Ben Vanderhyde began serving as their new Pastor on November 10, 2024.

Also among the Circuit Pastors are the retired Rev. Lawrence J. Dye, Rev. Kraig Gilkey. To God be the glory as the pastors and congregants of the Northeast Circuit of the Rocky Mountain District of the Lutheran Church - Missouri Synod receive His blessings of the forgiveness, of sins, life and salvation purchased with the blood of Jesus Christ and dispensed through Word and Sacrament! By His grace alone we will continue to proclaim Christ crucified and risen to ALL people in our area of God's Kingdom.

Rev. Hank Malone works diligently to keep the ministry alive as the demographics cause challenging issues. They are currently, with district and circuit help, determining what they can do to not only grow in number but to serve the community. They have for 125 years been a leading force in circuit and have housed ministry for children and ethnic ministry.

#### Redeemer – Salt Lake City

Their new pastor, Rev. Mark Below, serves this long-time congregation. Regular ministry continues to produce faithful members and the challenge is to restore the school to it's former standing in the community.

#### Grace – Sandy

Pastor Jeremy Lamont (SMP) is leading the congregation in worship and Bible Study as they begin the process of calling a new pastor and determining how to move their school into a successful future. They have a word and sacrament ministry on the south end of the metro area that is bringing Christ to a growing number of souls.

#### Holy Trinity - Riverton

With their new sanctuary built and serving the congregation, Rev. Al Borcher continues to work with his people to bring in worshippers and also to form plans at growing their school and CDC.

#### Good Shepherd - Richfield

Things are moving forward in wonderful ways under the leadership of Rev. Rob Bennett. The congregation hosts an annual golf tournament to introduce people to the church and are happy to host a growing number of LDS students hungry for the truth of God's Word.

#### Trinity – Cedar City

With their pastor, Rev. Bob Sharp, retiring, they look forward to preparing for a new pastor while continuing the ministries that currently serve the congregation and community. With their mortgage paid off, they are hoping growth and stewardship will allow them to flourish in the coming years.

#### Trinity – St. George

With their long-time principal, Duane Nyen retiring, a lot of attention has been turned to the school staff and possibilities for sustaining another 35 years of excellence. Rev. John Manweiler continues to inspire the congregation in their walk of faith.

#### LDS Ministry

God's blessings in the Western Circuit (which includes both our ups and downs):

**Concordia, Steamboat Springs** - After Rev. Craig Henningfield's retirement in October 2022, Rev. Jon Muhly was called and installed in March 2023. In January 2024, Concordia became an alliance congregation with Summit Mission Alliance, an LCMS RSO seeking to plant 10 congregations within the mountains of Colorado within 10 years. In August 2024, Concordia celebrated the installation of Rev. Dale Critchley, called as a missionary to Leadville, CO, through Summit Mission Alliance.

**Gracious Savior, Edwards** - continues to be faithfully served by Rev. Jason Haynes. "In the past three years Gracious Savior Lutheran Church continues to work to fulfill its Mission of Loving Jesus, Each Other, and All People. Partnering with youth and service organizations within the mountain community, we have reached outside of our facility to share the love and Good News of Jesus Christ. In addition to weekly Word and Sacrament ministry, we have reached approximately: 604 people with Discipleship events; 299 people with Service Project events; 1,506 people with Outreach events."

**Grace Fellowship, Gypsum** - continues to be faithfully served by Rev. Austin Kraft. Over the past three years they have added their first full-time admin/children's ministry position; have been blessed with 63% attendance increase; and plan to break ground on a new church building this spring (they are currently meeting in part of a furniture store which they rent).

**Faith, Craig** - continues to be faithfully served by Rev. John Turner. One of their members is in his first year of the SMP (Specific Ministry Pastor) program.

**Emmanuel, Rifle** - After Rev. Charles Westby resigned his call to Rifle, and the congregation worked through a reconciliation process, Rev. Dallas Dubke was called and installed in August 2024. Currently their school has grown to include Kindergarten - 2nd grade, with the hope adding more grades in the future, God willing.

Messiah, Grand Junction - continues to be faithfully served by Rev. Michael Redeker.

"2022 - Messiah School is still working to recover from school enrollment decline due to the pandemic [by God's grace and power]...Strategic planning will be on recruitment; looking to outside funding sources; [setting] up a specific endowment for the school using Jason Jones from Lutheran Church Foundation for long-term goal to fund the school...Messiah Church continues to keep the District as one of its important partners. Messiah's goal is to get back to 10% of Messiah's budget to support the district. One of our faculty took a call to the Nebraska district.

"2023 - Messiah's history included two pastors. However, with a huge shortage of pastors, the congregation agreed that good stewardship of church workers would be to go the DCE route in order to 'free up' another pastor to be used in the field. God provided us with a DCE, Jonathan Peterson..."

"2024 - After *many* years of prayer and searching, God provided us with a Principal/ Teacher. Sue Eberhard began at Messiah July 1, 2024. We are moving toward classical education. Transitioned to policy-based governance in summer of 2024."

**Our Savior, Vernal, Utah** - continues to be faithfully served by Rev. Derrick Brown, "providing Word and Sacrament ministry to LCMS Lutherans in Mormon-land."

**Immanuel, Paonia** - After Rev. Duane Daeke's death in October 2021, Rev. Kurt VanFossan was called and installed in August 2024.

**Faith, Carbondale** - After accepting a call to Trinity, Greeley, Rev. Joshua Vanderhyde's last service at Faith was in October 2023. During their vacancy, Faith has been faithfully served mainly by Rev. Jacob With (Mt. Calvary, Gunnison), with Rev. Dallas Dubke (Emmanuel, Rifle), and Rev. Kurt VanFossan (Immanuel, Paonia) leading services on alternating Sundays.

**Mt. Calvary, Gunnison** - Since 2020 continues Mount Calvary Lutheran Church in Gunnison continue to be faithfully served by Rev. Robert Carabotta. "Rev. Jacob With, who completed his seminary studies through the SMP Program, was ordained and installed as assistant pastor in 2022. Mount Calvary began its after-school Christian education program for elementary-age children in January 2023 where eleven children have been learning the Word of the Lord. From this program, one child was baptized in the Easter morning Divine Service in March of 2024! We were blessed in these four years to have four people receive the new birth in holy baptism and eight people confirmed into communicant membership by the rite of confirmation. #### **Our Savior Pagosa Springs, CO**

Our Savior Lutheran Church and School in Pagosa Springs has experienced much change. Rev. Packer took a call and finished his ministry at Our Savior in May of 2023. The school's headmaster, Rev. Odom, took a call around the same time. Rev. Atkinson accepted the call to be pastor of Our Savior and was installed on September 24th, 2023. After a year without a headmaster, Mr. Aaron Longmire took over the position while continuing to teach at the school. Mr. Byran Northcutt was installed this year to teach Grades 5-8. Grades K-8 has 57 students. There have been two preschool directors in the last triennium. The current director, Miss Molly Sprowle, has been doing a wonderful job with an enrollment of 36 students. The congregation also celebrated its 50th anniversary with a service and meal. President Rev. Maxwell preached during the service as an honored guest. Finally, the organist and exceptional volunteer, Leah Hellerich, has decided to retire and move closer to family.

#### Lutheran Mercy Care Ministries (LMCM)

LMCM, as part of our Mercy ministries at OSLC in Pagosa Springs, continues to grow. We have served 270 individuals since the start of the ministry in 2014; we are in regular contact with 50 to 60 individuals either in county jails, prisons or on the outside. The congregation baked more than 30 dozen cookies for the Kairos Prison Ministry and as part of the Angel Tree program purchased 32 Christmas gifts for children of the incarcerated.

#### St. Paul's Durango, CO

St. Paul's Lutheran Church in Durango, Colorado is in the middle of a ministry expansion campaign. The project seeks to refurbish an aging property with a focus on accessibility and safety as well as making it useful for future ministry opportunities. All of these improvements are being carefully considered to enhance the preaching of the Word and administering of the holy Sacraments.

#### **Trinity Cortez, CO**

Trinity Lutheran Church in Cortez, Colorado, has experienced growth and outreach over the past three years. Worship attendance has steadily, but slowly, rebounded post-pandemic, nearing pre-pandemic levels by the end of 2023 and stabilizing in 2024 with an average of 70 in-person and ~10 online attendees weekly. Seasonal services like Christmas and Easter have maintained consistent participation. Since 2022, 40 people have joined our congregation, including 8 in the past year. However, we have lost 20 members due to death and other reasons. Our membership stands at 156 communicants and 182 baptized members. While we grieve the loss of those who passed away, several have served God's kingdom after their death by leaving behind memorial gifts supporting evangelism and campus improvements.

Our confirmation program, now a weekly model, has fostered strong engagement, leading to 3 youth confirmations in 2023, 4 youth confirmations in 2024, and 3 youth currently enrolled. Our preschool, stabilized under consistent leadership, continues to receive weekly chapel lessons and has received grants and gifts to upgrade its facilities. While enrollment remains challenging in a competitive market, the preschool's efforts are bearing fruit. In January 2024, we started an annual celebration by participating in National Lutheran Schools Week.

Outreach and community engagement remain a key focus of our mission. Collaborations with the Montezuma Ministerial Alliance and events like the Night of Praise in the Park and a Back-to-School Backpack Giveaway (distributing 749 backpacks) have strengthened ties with our community. Monthly nursing home services average 48 attendees, and our annual Church Picnic and seasonal worship services continue to draw visitors.

Facility and technology improvements, including a new sound system and PTZ video camera, enhance our worship and outreach capabilities. Despite inflation's impact on operational costs, God's provision and faithful stewardship have kept us financially stable. Through worship, education, outreach, and fellowship, Trinity Lutheran Church continues to see God's blessings. We look forward to another year Preaching the Cross in the Four Corners.

#### Zion Farmington, NM

Zion Lutheran Church in Farmington serves our members and the community with two worship services each week. The primary service is on Sunday morning and a Thursday afternoon service which is shortened from the Divine service that takes place on Sunday. We have recently formed a partnership with the local Grace Place and we look forward to seeing that develop and grow in helping young families and possibly helping them to become disciples of Christ. We continue to assist Birthright with baby clothing and defending the right to life in this world of our Heavenly Father.

By God's grace the congregation grew in the last triennium receiving 16 new members through Holy Baptism. The youth participated in a servant event at our sister congregation Christ Our Savior in Angel Fire, NM in June, 2023. **St. Andrews Lutheran Church, Albuquerque, NM** – Nearly ten years ago St. Andrews began as an Hispanic outreach in Albuquerque's south valley. The Sandia Circuits Forum and Faith in Christ Lutheran Church, Albuquerque, supported the project. Currently, Rev. Aaron Rickert of Grace Lutheran Church, Albuquerque, is the primary guest pastor. The congregation has moved from its strip mall on Gun Glub and Coors Rds. to its new meeting place, the Church of Our Lord, ANC, on Isleta Blvd. The Divine Service is at 3 pm Sunday afternoons. Catechism study follows. In January, 2025, St. Andrews hosted the Sandia Circuits Forum. Estimated statistics are: Baptized, 17. Confirmed, 15. Av'g attendance, 12. The congregation is officially vacant.

**Immanuel Lutheran Church, Albuquerque, NM** – Immanuel is the mother church for several LCMS congregations in New Mexico. The church meets in a beautiful traditional New Mexico pueblo style building. Its people are warm and welcoming with a heart for missions and Christian education. Immanuel Lutheran School has a reputation of providing an excellent Christian education. Following COVID 19, enrollment at the school declined and continuation has been difficult. Members have rallied to support the school and Immanuel Lutheran School remains open. Ably served by Rev. Dustin Kear, Immanuel has the largest communicant membership in the Albuquerque area. Estimated statistics are: Baptized, 493. Confirmed, 404. Av'g attendance, 140.

**Redeemer Lutheran Church, Albuquerque, NM** – Organized in 1951, Redeemer Lutheran Church had its closing service December 29, 2024. Rev. Donald Neidigk, Sandia South, Circuit Visitor was the preacher assisted by former pastors Rev. Lyle Stuehrenberg and Rev. John Heffelfinger. Changing demographics in the neighborhood, declining membership and concern for the safety of worshipers led the congregation approve merger with Faith in Christ Lutheran Church. Members are deliberating the future of Redeemer's building and pipe organ. The merged congregation chose as its new name Christ Our Redeemer Lutheran Church and is served by Rev. Bruce Wilder. Christ Our Redeemer is a congregation of the Sandia North Circuit. Located at Chelwood and Indian School, attendance at the merged church is about 85 per Sunday.

**Calvary Lutheran Church, Rio Rancho, NM** – Calvary Lutheran Church is served by Rev. Adam DeGroot. Estimated statistics are: Baptized, 493. Confirmed, 404. Av'g attendance, 140. A congregational report had not been received as of this writing.

## **CONSTITUTION COMMITTEE**

The District Constitution Committee (DCC) RMD has examined thirty-four (34) congregational constitutions and bylaws from Spring, 2022 through Spring, 2025. They are studied and compared to the "LCMS Guidelines For The Constitution And Bylaws Of A Lutheran Congregation". The Office of Secretary LCMS and CTCR were also consulted on various questions. Seventeen (17) were submitted to the District Board of Directors for their approval. Twenty-two (22) are pending action by the DCC and congregations for further consideration to meet Synodical Guidelines and/or to resolve some noted issues. Most of the reviews have been focused on changes and updates for existing constitutions and bylaws.

It is interesting to note, multiple congregations have requested adding statements of belief (such as sanctity of marriage, right to life, sexual identification, etc.) to their constitution or bylaws which we have encouraged them to reconsider as these are valued but as they are LCMS beliefs, singling out one doctrinal understanding tends to diminish other doctrinal positions of the LCMS.

#### Repeating Synod's Statements on Issues:

All the issues for which our Synod has taken a stand are covered by simply stating that we are a congregation of the Lutheran Church-Missouri Synod. It is not necessary, and possibly improper, to repeat them in a congregation's constitution or bylaws. If one of Synod's stances on an issue is repeated in a congregation's constitution or bylaws, what is to be interpreted for Synod's other stances on issues? Are they agreed to or disagreed to by the congregation? Can taking a position on one issue but not other issues possibly result in some sort of legal action? It is also unnecessary to repeat scriptural positions, such as stating that marriage is between a man and a woman, in a congregation's constitution or bylaws. These scriptural positions are all covered in the required Confessional Standard Article (usually Article III) of the constitution. If a congregation feels it is necessary to make a statement on an issue, a proper place for it would be in a handbook, policy manual, operating procedures, etc. which can be referenced in a bylaws article but which does not have any constitutional or bylaws authority or standing. Congregations don't have to purposely avoid the issues but just speak to them and take positions on them in the proper environment whereas the constitution and bylaws are not that proper environment.

This has been suspended for now.

I attended the LCMS District Life Coordinator meeting at the LCMS International Center November 9-11, 2022.

Presentations on Sanctity of Life were given at the following: LWML South Central Zone Spring Rally, April 2023; LWML North Central Zone Fall Rally, October 2023; LWML Meeting at Risen Savior Broomfield, January 2025.

The first Colorado March For Life was April 12, 2024. I attended planning meetings, promoted the event to our Colorado churches and pastors, coordinated LCMS participation including the LCMS Prayer Service prior, arranged for bus transportation from north of Denver, and hosted an exhibitors table along with the Denver Chapter Lutherans For Life. Planning is currently underway for the 2025 Colorado March For Life, which will be on April 11.

#### LCEF's Response



The LWML from its inception has encouraged and promoted Bible study, fellowship, and mentoring in organizational and leadership skills. Missions are supported through prayer and monetary contributions, collected as coins or dollars in mite boxes, checks, or electronic giving. Patterned after the story of the poor widow that gave her "mites" as an offering to God, LWML "mites" are also offered with prayer.

A new mission goal is established each biennium. The Mission Goal for the 2023-2025 Biennium is \$2,350,000.00. Thirty-one mission grants were selected.

The LWML Rocky Mt. District consists of Colorado, New Mexico, Vernal, UT, Page, AZ, and El Paso, TX. The district consists of 10 Zones with 80 active groups a membership of 1270. Groups have gathered in person and virtually. Virtual workshops and Bible studies as well as in-person Bible studies, retreats, and zone events have encouraged women within the district to support and encourage each other across the miles. Mites are collected at the group, zone, and district level. 25% of mites collected in the district are designated to fund LWML Mission Grants on the national level. The remaining 75% remain in the district to fund LWML RMD Mission Grants and Scholarships. The 2024 Mission Goal was \$118,000.00.

## **MISSION RETHINKING COMMITTEE**

#### Rocky Mountain District Mission Planting Reconfiguration

#### Introduction

Prior to His ascension, our Lord commissioned His followers to make disciples throughout the world. (Matthew 28:19-20, Mark 16:15, Luke 24:45-47, John 20:21, Acts 1:8) Ever since, the church has been involved in mission planting. However, since the beginning of the 21<sup>st</sup> century, our district – The Rocky Mountain District of the Lutheran Church Missouri Synod (RMD) – has seen the number of congregation closures far exceed the number of new church plants and mission starts. There are multiple reasons for this, but we are confident that we should not accept this reality lying down. It is from this conviction that a new mission structure is being proposed.

This is not the first attempt at reconfiguring missions in the RMD. At the 2012 RMD convention, the district voted to adopt the Gospel Gaps Paradigm (GGP), a circuit-based mission model. There were good things that came from the GGP, namely the highly relational nature of missions that required networking between congregations. However, there were also some weaknesses of this model that were exposed. For one, circuits are not legal or official ecclesial entities and therefore have no financial or calling power. Second, the small number of congregations in each circuit means that most circuits don't have the capacity to undergo a full-blown mission planting effort. Finally, most of the pastors within circuit congregations are consumed with the day-to-day affairs of congregational ministry and therefore don't have the capacity to give the time and energy necessary to mission efforts.

The newly proposed mission model presented before the RMD convention for approval attempts to combine the things we've learned from previous mission models while also being good and faithful stewards of the resources that we have at the RMD so that we can maximize the impact of the Gospel of Christ in our district. We believe it is crucial to maintain the relational emphasis of the GGP but also provide stronger support and clearer parameters from the district level. We also hope to minimize the amount of bureaucracy required to receive RMD support. With the Lord's help, we desire to mitigate the roadblocks and help identify the opportunities for mission planting in our district.

#### The Regional Strategic Teams Mission Planting Model

In this newly proposed mission model, Regional Strategic Teams, will be facilitated with the help of the area Vice Presidents (VPs), to encourage and assist mission planting in the four areas of RMD. It is the hope that by having the VPs actively encouraging the Circuits in their areas, these Regional Strategic Teams will provide stronger ties between the RMD and its local missions than the GGP sometimes did, while still maintaining its relational and networking emphasis.

It is also important to note in the flexibility of this model that when the future Mission Executive begins serving, they would also be an active participant in these Regional Strategic Teams for guidance and synodical resource networking.

#### Conclusion

It is our hope and prayer of the that our district becomes a place where the kingdom of God is tangibly and intentionally being expanded through the planting of new Word and Sacrament missions. We seek to strategically use the resources God has given to us while also trusting in His Spirit's guidance and provision to accomplish this. To this end, please join us in fervent prayer to the Lord of the Harvest for the success of His mission amongst us. To God alone be the glory!

#### Opinion

#### ROCKY MOUNTAIN DISTRICT of THE LUTHERAN CHURCH-MISSOURI SYNOD NOTES TO FINANCIAL STATEMENTS

#### NOTE A – NATURE OF ORGANIZATION

The Rocky Mountain District (the District), a religious not-for-profit organization, is one of 35 districts of The Lutheran Church—Missouri Synod (the Synod), encompassing 168 congregations in the states of Utah, Colorado, New Mexico, and the cities of El Paso, Texas; Page, Arizona; Big Spring and Venango, Nebraska. The Synod established its district offices to more effectively achieve its objectives and assist its congregations and their members in conserving and promoting the unity of the faith and in carrying out their mission and ministry.

The District relies on donations from its member congregations for a significant portion of its support. As shown in the Statement of Activities, support from District congregations totaled \$951,581 and \$962,257 for the years ended January 31, 2024 and 2023, respectively. These donations are subject to fluctuations in the economic status of the areas in which the congregations are located. No provisions have been made for changes in the economic environment. Any significant reduction in the level of this support, however, could have an effect on the District's program and supporting activities.

The costs of providing various program and other supporting services have been summarized on a functional basis in the Statement of Activities as follows:

- World and National Missions World missions includes the District's personalized world ministry support remitted to the Synod. National missions includes but is not limited to North American new mission work, campus ministries, deaf ministries, ethnic ministries, urban ministries, congregational subsidy, evangelism efforts, human care ministries, and related conferences and events.
- Preparing Church Workers Includes financial aid provided to students normally attending one of the six universities or two seminaries of the Synod.
- Congregational Services Supports District congregational service efforts and includes but is
  not limited to activities such as Sunday School, confirmation, family life, day care, adult
  education, outdoor ministry, singles ministry, elementary and secondary education, youth
  services, worship, stewardship education, and related conferences and events.
- Synodical Budget Includes remittances to the Synod for synodical budget support.
- Mission and Ministry Support Includes the District's communication efforts, financial and general service activities, the operation/maintenance of District office facilities, District/Synodical convention expenses.
- Ecclesiastical and Program Administration Includes activities of the president's office, vice-presidents, circuit visitors, reconcilers, and related conferences and events, as well as support of the District Board of Directors and its related committees.

All of these program and support services include the related program and administration expense associated with that particular function.

#### ROCKY MOUNTAIN DISTRICT of THE LUTHERAN CHURCH-MISSOURI SYNOD NOTES TO FINANCIAL STATEMENTS

#### NOTE A - NATURE OF ORGANIZATION (Continued)

The Rocky Mountain District of the Synod is an organization described in Section 501(c)(3) of the Internal Revenue Code (IRC) and, by virtue of a group tax-exempt ruling to the Synod and its component parts, is exempt from federal income taxes. However, any unrelated business income may be subject to taxation. In addition, the District qualifies for the charitable contribution deduction under IRC Section 170(b)(1)(A) and has been classified by the Internal Revenue Service as an organization other than a private foundation.

#### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies followed by the District are described below:

#### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### Use of Estimates

We use estimates and assumptions in preparing financial statements in conformity with generally accepted accounting principles (GAAP). Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of revenues and expenses. Actual results could differ from those estimates, and those differences could be material.

#### Principles of Consolidation

The accompanying financial statements include all administrative and program offices or departments of the Rocky Mountain District. They do not include the assets, liabilities, and operations of the congregations, schools, and other separately administered operations of the Synod within the District's geographic area.

#### Cash, Cash Equivalents, and Restricted Cash

For financial statement purposes, we consider all cash and highly liquid financial instruments with original maturities of three months or less, which are not held for or restricted by donors for long-term purposes (e.g., for building projects, perpetual endowments), to be cash and cash equivalents. Cash restricted by donors for long-term purposes is shown separately in the Statement of Financial Position.

#### Investments and Net Investment Return/(Loss)

We record investment purchases at cost, or if donated, at fair value on the date of receipt. Thereafter, investments are reported at their fair values in the Statement of Financial Position. Net investment return/(loss) consists of interest and dividend income, realized and unrealized capital gains and losses, less external investment expenses; it is reported in the Statement of Activities based on the existence or absence of donor-imposed restrictions.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### Contributions Receivable

Unconditional promises to give that are expected to be collected within one year are recorded at net realizable value. Unconditional promises to give expected to be collected after one year are initially recorded at fair value using present value techniques, incorporating risk-adjusted discount rates designed to reflect the assumptions market participants would use in pricing the asset. In subsequent years, amortization of the discounts is included in contributions/support in the Statement of Activities. We determine the allowance for uncollectible promises to give based on historical experience, an assessment of current economic conditions, and a review of subsequent collections. Contributions receivable are written off when deemed uncollectible.

#### **Property and Equipment**

Property and equipment purchases of \$5,000 or more with an estimated useful life greater than one year are capitalized and recorded at cost, or if donated, at fair value on the date of receipt. Depreciation is computed using the straight-line method over the estimated useful lives of the assets ranging from 3 to 50 years, or in the case of capitalized leased assets or leasehold improvements, the lesser of the useful life of the asset or the lease term. When assets are sold or otherwise disposed of, the cost and related depreciation are removed from the accounts, and any resulting gain or loss is included in the Statement of Activities. Costs of maintenance and repairs that do not improve or extend the useful lives of the respective assets are expensed when incurred. Property held for sale is recorded at the lower of cost or estimated fair value.

We review the carrying values of property and equipment for impairment whenever events or circumstances indicate that the carrying value of an asset may not be recoverable from its use and eventual disposition. When considered impaired, an impairment loss is recognized in the Statement of Activities to the extent carrying value exceeds the fair value of the asset.

#### **Beneficial Interests in Perpetual Trusts**

We have been named as an irrevocable beneficiary of several perpetual trusts held and administered by the LCMS Foundation. Perpetual trusts provide for the distribution of the net income of the trusts to the District; however, we will never receive the assets of the trusts. At the date we receive notice of a beneficial interest, a contribution with donor restrictions of a perpetual nature is recorded in the Statement of Activities and a beneficial interest in perpetual trust is recorded in the Statement of Financial Position at the fair value of the underlying trust assets, as determined/calculated by the LCMS Foundation. Thereafter, beneficial interests in the trusts are reported at the fair value of the trusts' assets in the Statement of Financial Position, with trust distributions and changes in fair value recognized in the Statement of Activities.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### Grants Payable

Unconditional promises to give which have been authorized and communicated to the recipient are reported as liabilities and expenses in the period in which the notification to the recipient occurs. If at the time the promise is made, the District expects to make payment in one year or less, the payable is recorded at net settlement value. Unconditional promises that the District expects to pay in more than one year are reported at fair value, which is measured as the present value of the amounts to be paid.

#### Net Assets

Net assets, revenues, gains and losses are classified based on the existence or absence of donorimposed restrictions. Accordingly, net assets and changes therein are classified and reported as follows:

Net Assets Without Donor Restrictions – Net assets available for use in general operations and not subject to donor restrictions. These net assets may be subject to self-imposed limits by action of the governing board. These board-designated net assets may be earmarked for future programs, contingencies, purchase/construction of fixed assets, or for other uses.

*Net Assets With Donor Restrictions* – Net assets subject to donor-imposed restrictions. Some donorimposed restrictions are temporary in nature, such as those that will be met by the passage of time or other events specified by the donor. Other donor-imposed restrictions are perpetual in nature, where the donor stipulates that resources be maintained in perpetuity. Donor-imposed restrictions that are temporary in nature are released when a restriction expires, that is, when the stipulated time has elapsed, when the stipulated purpose for which the resource was restricted has been fulfilled, or both.

#### **Contributions and Revenue Recognition**

Contributions are recognized as support in the Statement of Activities when cash, securities or other assets, an unconditional promise to give, or notification of a beneficial interest is received. Gifts of long-lived assets with explicit restrictions that specify how the assets are to be used and gifts of cash that must be used to acquire long-lived assets are reported as support in net assets with donor restrictions. Absent explicit donor restrictions about how long those long-lived assets must be maintained, we report expirations of donor restrictions when the donated or acquired long-lived assets are placed in service. Conditional promises to give are not included as support until the conditions on which they depend have been substantially met and the promises become unconditional. Donated services are reported as support in the Statement of Activities at fair value when those services (1) create or enhance nonfinancial assets or (2) require specialized skills, are provided by individuals possessing those skills, and would typically need to be purchased if not provided by donation.

Revenue is recognized when earned. Program and supporting activity fees and payments received in advance are deferred to the applicable period in which the related services are performed or expenditures are incurred.

#### Functional Allocation of Expenses

The costs of program and supporting service activities have been summarized on a functional basis in the Statement of Activities. The Statement of Functional Expenses presents the natural classification detail of expenses by function. The financial statements include certain categories of expenses that are attributable to more than one program and supporting function. Therefore, these expenses require allocation to the programs and supporting services benefited on a basis that is reasonable and consistently applied. The expenses that are allocated include compensation and benefits, which are allocated based on estimates of time and effort.

#### Taxes

We follow the accounting standards for contingencies in evaluating uncertain tax positions. This guidance requires financial statement recognition of the impact of a tax position if a position is more likely than not of being sustained on audit by the applicable regulatory authority, based on the technical merits of the position. These rules also provide guidance on measurement, recognition, classification, interest and penalties, transition, and disclosure requirements for uncertain tax positions. No liability has been recognized by the District for uncertain tax positions as of January 31, 2024 and 2023.

#### Financial Instruments and Credit Risk

We manage deposit concentration risk by placing cash and financial instruments with financial institutions believed by us to be creditworthy. At times, amounts on deposit may exceed insured limits or include uninsured investments in LCEF notes, money market mutual funds, etc. To date, we have not experienced losses in any of these accounts. Credit risk associated with accounts and contributions receivable is limited due to high historical collection rates and because substantial portions of the outstanding amounts are due from our member congregations or other agencies of the Synod who are supportive of our mission. Investment performance is monitored by the Board of Directors and management. Although the fair values of investments are subject to fluctuation from year-to-year, we believe the investment policies and guidelines are prudent for the long-term welfare of the organization.

#### Reclassifications

Certain amounts in the prior year financial statements have been reclassified for comparative purposes to conform to the 2024 financial statement presentation. These reclassifications, however, had no effect on the previously reported total net assets or total change in net assets.

#### Subsequent Events

The District has evaluated subsequent events through December 23, 2024, the date the financial statements were available to be issued.

As part of its liquidity plan, excess cash is invested in short-term investments, including LCEF certificates. As disclosed in Note G, the District also has an unsecured line of credit with LCEF which is available to meet cash flow needs.

#### NOTE D - FAIR VALUE MEASUREMENTS

We report certain assets and liabilities at fair value in the accompanying financial statements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Inputs used to determine fair value refer broadly to the assumptions that market participants would use in pricing the asset or liability, including assumptions about risk. Inputs may be observable or unobservable. We consider observable data to be market data that is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, and provided by independent sources that are actively involved in the relevant market.

A fair value hierarchy is used to disclose the measurement of fair value based on the levels of observable or unobservable inputs as follows:

Level 1 Inputs – Quoted prices are available in active markets for identical assets or liabilities as of the measurement date. A quoted price for an identical asset or liability in an active market provides the most reliable fair value measurement because it is directly observable to the market.

Level 2 Inputs – Pricing inputs are other than quoted prices in active markets, which are either directly or indirectly observable as of the report date. Level 2 inputs include assets or liabilities for which quoted prices are available but traded less frequently and assets or liabilities that are fair valued using similar assets or liabilities, the parameters of which can be directly observed.

Level 3 Inputs – Assets or liabilities have little to no pricing observability as of the measurement date. These items are measured using management's best estimate of fair value, where the inputs into the determination of fair value are not observable and require significant management judgment or estimation.

In some cases, the inputs used to measure the fair value of an asset or liability might be categorized within different levels of the fair value hierarchy. In those cases, the fair value measurement is categorized in its entirety in the same level of the fair value hierarchy as the lowest level input that is significant to the entire measurement. Assessing the significance of a particular input to entire measurement requires judgment, taking into account factors specific to the asset or liability. The categorization of a financial instrument within the hierarchy is based upon the pricing transparency of the instrument and does not necessarily correspond to our assessment of the quality, perceived risk, or liquidity profile of the asset or liability.

#### NOTE F - GRANTS PAYABLE

#### NOTE G - LINE OF CREDIT

LCEF establishes a line of credit for each participating district based on the district's program performance; this line of credit is evaluated and adjusted by LCEF annually in July. As of and for the years ended January 31, 2024 and 2023, we had an unsecured line of credit with LCEF in the amount of \$420,440 and \$419,616, respectively. Borrowings under the line would bear interest at the current rate of 3.875%. As of and during the years ended January 31, 2024 and 2023, there were no borrowings against this line of credit.

#### NOTE J - ENDOWMENT FUNDS

Our endowment (the Endowment) consists of three individual funds established by donors to provide annual funding for specific activities, including world and national missions, preparing church workers, and congregational services. The Endowment also includes certain net assets without donor restrictions that have been designated for endowment by the Board of Directors.

The District classifies amounts in its donor-restricted endowment fund as net assets with donor restrictions until the Board of Directors appropriates amounts for expenditure and any purpose restrictions have been met. Our Board has interpreted the Colorado enacted version of the Uniform Prudent Management of Institutional Funds Act (UPMIFA) as requiring the preservation of the fair value of the original gift of the donor-restricted endowment funds, as of the gift date, unless there are explicit donor stipulations to the contrary. As a result of this interpretation, we retain in perpetuity (a) the original value of initial and subsequent gifts donated to the endowment and (b) any accumulations to the endowment that are required to be maintained in perpetuity in accordance with the applicable donor gift instrument. Donor-restricted amounts not retained in perpetuity are subject to appropriation and expenditure by us in a manner consistent with the standard of prudence prescribed by UPMIFA. We consider the following factors in making a determination to appropriate or accumulate donor-restricted endowment funds:

- The duration and preservation of the endowment fund
- The purposes of the organization and the donor-restricted endowment fund
- General economic conditions
- The possible effect of inflation and deflation
- The expected total return from income and the appreciation of investments
- Other resources of the District
- The investment policies of the District

We have interpreted UPMIFA to not permit spending from underwater endowments in accordance with prudent measures required under law. One donor-restricted endowment fund was underwater by \$6,051 and \$13,321, at January 31, 2024 and 2023, respectively.

Investment and Spending Policies – The District Board of Directors has delegated the responsibility for managing and investing its endowment assets to the respective committees appointed by the Board; all committee actions are subject to oversight by the Board of Directors. The District has adopted investment and spending policies for endowment assets that attempt to subject the fund to low investment risk and provide programs supported by its endowments with current income. Endowment assets are invested in LCEF certificates and a mutual fund. The various endowment fund committees are responsible for determining investment objectives, goals, and risk tolerances in relation to the funds purpose and stated mission of the District and in concert with spending objectives. It is the intention of the District to increase the revenue stream when possible and the total endowment investment return expended for current operations or reinvested will be balanced to provide equitably for both current and future needs of the District and/or its endowment.

No more than 3% of the principal may be invaded each calendar year, and expenditure of such principal requires a two-thirds majority vote from the respective committee and the Board of Directors. Additionally, any unspent investment return should remain in the endowment fund for future growth.

### NOTE K – SUPPORT AND REVENUE FROM THE LUTHERAN CHURCH EXTENSION FUND

Distribution of LCEF Operating Results – Based on LCEF's annual operating performance, earnings distributions are made available to its partner districts. LCEF operating results are restricted for specific mission and ministry programs of the respective district and are distributed upon request. During the years ended January 31, 2024 and 2023, the District requested and received a distribution of LCEF operating results in the amount of \$115,989 and \$233,940, respectively. This distribution is reflected in the Statement of Activities as support from LCEF in net assets with donor restrictions.

#### NOTE L - DEFINED BENEFIT PLAN

The District participates in the worker benefit plans of the Synod, including the Concordia Retirement Plan (CRP). The CRP provides individuals with post-retirement benefits. Substantially all full-time employees (those employed more than 20 hours per week and at least five months per year) are covered by the CRP. Employees are vested after five years of creditable service. We contribute a fixed percentage of each participant's salary to the CRP. Retirement plan expenses for the years ended January 31, 2024 and 2023, totaled \$28,794 and \$23,243, respectively.

There were no significant changes in the District's relationship to the CRP during fiscal 2024 or 2023. There were also no contingent liabilities associated with the CRP at January 31, 2024 or 2023. Currently, the District has no intention to withdraw from the CRP.
