STANDING RULES FOR 2025 RMD CONVENTION

- 1. The chair will follow the printed agenda as closely as possible.
- 2. Each member of the Convention, when recognized by the Chair, is asked to state his/her name. Please also state the name of his/her congregation and location or the administrative unit he/she represents.
- 3. Those who speak from the floor will limit their remarks to two minutes (not applicable to the Floor Committee, but suggested).
- 4. Any voting delegate may "call the question." This is not debatable, but requires a 2/3 vote. The question may not be called by a speaker immediately after speaking for or against the question. At the expiration of 30 minutes of debate on any question, the Chair shall automatically call the question.
- 5. A point of information is always in order. No points of information or points of order are taken during a vote.
- 6. When speaking to a motion, please say, I speak for (against) the motion, and then continue with your rationale.
- 7. If lengthy discussion is perceived, the Chair will ask for a pro/con mode. This means that those in favor of the resolution would go to the pro microphone and those opposed would go to the con microphone.
- 8. When a substitute motion is made and seconded, the Chair gives the delegate making the motion two minutes to explain his/her rationale. The Chair then asks the assembly to vote by simple majority whether it wishes to consider the substitute motion. If the assembly votes in favor of consideration, the substitute motion is then on the floor and the original motion is set aside. If the substitute motion, amended or unamended, is subsequently adopted , it replaces the original motion, which then dies. If the substitute motion is either not considered or subsequently is defeated, the original main motion, amended or unamended, is back on the floor for consideration.(Behnken Rule for dealing with substitute motions, as observed by The Synod).
- 9. While the "whereas" clauses are considered an integral part of each overture, only the "resolved" will be read by Floor Committees when presenting an overture, unless requested by the Chair of in their judgment each whereas should be stated.
- 10. Resolutions prepared by the Floor Committees which are not acted upon by the Convention before adjournment die.
- 11. Unless covered by these standing rules of the convention, parliamentary procedure shall be governed by **Roberts Rules of Order**, newly revised edition. Above all, the rules of Christian love govern the convention.
- 12. Please remember that the purpose of parliamentary procedure is to carry out the wishes of the assembly in an orderly manner, to expedite business, and to insure fairness to all, both the majority and the minority. It is not the purpose of parliamentary procedure to make the conduct of business in an assembly difficult.

STANDING RULES FOR 2025 RMD CONVENTION

- 13. Please prepare to submit all motions (or substitute motions) and amendments with more than five words in writing with a copy to the District Secretary.
- 14. Late overtures to the Floor Committees are considered only on the basis of urgency.
- 15. Please turn off or silence cell phones.
- 16. Approval of the minutes of the previous day's business will take place at the first business session following their distribution. Correction involving or implicating convention action shall be offered from the floor. Spelling, formatting and editorial corrections shall be submitted to the Secretary in writing for subsequent inclusion in the minutes.



NOMINATING COMMITTEE

Per the RMD Constitution and Bylaws (Art. III, 3.01A "Responsibility for Nominations"), the Nominating Committee elected by the District Convention shall consist of five members: two ordained ministers, two laypersons and one commissioned minister. There shall be one ordained minister or one layperson elected from each of the four geographic areas of the District [Cf. Bylaws Art. I, 1.04 "Geographic Regions"]. The commissioned minister shall be elected from the District at large.

At the 2022 Convention, the District Nominating Committee elected for the 2022-2025 Triennium included: Rev. Douglas K. Escue (ordained, Southern region), Rev. Andrew Packer (ordained, Western region); Kimberly Bower (lay person, Central region); the 2022 Convention concluded without electing a full slate for the Nominating Committee—no Commissioned Minister from the District at large.

In 2023, Rev. Packer took a Call outside of the District. Rev. Jeremy Jacoby (ordained) was appointed to fill the vacancy on the committee from the Central region. Rev. Escue was appointed chairman of the committee by the District President.

In November 2024, a Nominations Packet from Secretary Lietzau and RMD Nominating Committee Escue was sent to all RMD congregations containing instructions about nominations/suggestions for the 2025 Convention Election Ballot.21 RMD Pastors, four Commissioned Ministers, and 18 lay persons were nominated/suggested for various positions. The committee completed its work by mid March.

The slate of candidates, as tabulated by the District Secretary and Nominations Committee Chairman, is presented in the order of election: District President, First Vice President, Area Vice President, Secretary, Board of Directors, Nominations Committee, and Synod's Committee for Convention Nomination. Where the By-Laws require election by Geographical Area, the respective area is printed in the Slate of Candidates. Voting delegates will be able to identify the incumbents serving in the current Triennium by the asterisks beside their name.

The Committee wishes to thank all RMD congregations who nominated and suggested names for the election. The Committee wish to thank all those who consented to serve for election. Special thanks goes to RMD Administrative Assistant Monique Hjalmquist for her gentle nudging, patience and assistance to the committee.


